## About ITEE

Information Technology Engineers Examination (ITEE) is the national level IT Engineers Examination adopted by the Government of Bangladesh. Bangladesh is conducting ITEE exam twice a year from October 2013.

It is started in Japan and widely accepted by the Japanese IT Companies. Now, ITEE is one of the largest national qualification examination with around 600,000 applicants each year in Japan. Japanese IT/ITES companies are accepting ITEE certified professionals and Government of Japan also giving Preferential Immigration Treatment for them.

## ITEE in Asia

- ITEE qualification is widely accepted in Asian region. It is adopted in Philippines, Malaysia, Mongolia, Myanmar, Thailand, Vietnam and Bangladesh. It is also mutually recognized in China, Taiwan, India, Japan, Korea and Singapore. As of now, an agreement of mutual recognition on ITEE examination has been made amongst 13 countries in Asia.




- ITPEC (IT Professionals Examination Council) is an organization to co-ordinate all the efforts of member countries in the implementation of IT Engineers Skill Standards and IT Engineers Examinations in Asia. Bangladesh has joined as ITPEC member country on 1 September 2014. Member countries of ITPEC are Philippines, Malaysia, Mongolia, Myanmar, Thailand, Vietnam and Bangladesh.

## ITEE Exam

- ITEE examination is conducted on the same date and time with the same set of questions among all the ITPEC member countries.

- The examination is conducted twice a year, generally in April and October.
- There are currently four exams being offered by Information Technology Professionals Examination Council (ITPEC):



1. Level-1: IT Passport Exam (IP): [This examination is for testing knowledge of IT literacy. It is suitable for non-IT professionals and graduates who needs to show their IT literacy capability.]
2. Level-2: Fundamental Information Technology Engineer Examination (FE): [This examination is suitable for IT professionals and graduates and 4th years' CSE/IT related students.]
3. Level-3: Applied Information Technology Engineer Examination (AP) [This examination is suitable for experienced IT professionals.]
4. Level-4: Advanced Examination (AE) [This examination is suitable for domain specific experienced IT professionals.]

## ITEE in Bangladesh

Bangladesh government is conducting and implementing ITEE in Bangladesh by Bangladesh IT-engineers Examination Center (BD-ITEC) of Bangladesh Computer Council under the umbrella of ICT Division, Ministry of Posts, Telecommunications & IT. It is the national level examination for IT professionals/graduates in Bangladesh. Non-IT Professionals/graduates also can achieve international recognition for their IT knowledge & skills. BD-ITEC is conducting ITEE in Bangladesh from October 2013 regularly. The following two exams are conducted in Bangladesh now:

1. Level-1: IT Passport Exam (IP): [This examination is for testing knowledge of IT literacy. It is suitable for non-IT professionals and graduates who needs to show their IT literacy capability.]
2. Level-2: Fundamental Information Technology Engineer Examination (FE): [This examination is suitable for IT professionals and graduates and 4th years' CSE/IT related students.]



## Certificate/Award

- All ITEE passers get certificate from Bangladesh government. Certificate is jointly signed by the Secretary, ICT Division, Ministry of Posts, Telecommunications & IT and the Executive Director, Bangladesh Computer Council.
- Top three highest scorers of Bangladesh have the opportunity to receive "Certificate of Excellence Award" from Information-technology Promotion Agency (IPA), Japan, *depending on examination score and number of passers*.
- Top three highest scorers among all ITPEC member countries get "ITPEC Examination Award" from Information-technology Promotion Agency (IPA), Japan.
